VANDE MATARAM SCHEME LAUNCHED

Shillong, February 9, 2004: The Office of the Deputy Commissioner, East Khasi Hills District, in collaboration with The Federation of Obstetrics & Gynaecological Society of India, today launched the Vande Mataram Scheme at the Milliona Hall, Ganesh Das Hospital, Shillong. Doctors from various private institutions, Headmen and Non-Governmental Organisations were present at the function being presided over by Mr. D P Wahlang, Deputy Commissioner, East Khasi Hills District. Dr. O P Agarwal, DHS (MCH & FW) was the Chief Guest on the occasion, while Dr. I Rynjah, Director of Health Services (MI) was the Guest of Honour.

While stating that Vande Mataram is a Sanskrit word, which means 'I salute my mother most respectfully', Dr. Agarwal said that this programme, started by the Government of India envisages free treatment for pregnant women on every 9th of the month at specified centres. He said that this scheme, specially meant for mothers cannot be achieved by Government institutions because they do not have sufficient experts. He added that the scheme will be made possible only if there is an integration between Government and Private Institutions and also the involvement of non-governmental organisations.

Lamenting that in India, 400 out of 1 lakh mothers died post delivery, Dr. I Rynjah, in her speech as the Guest of Honour, said that the aim of the Central Government in launching this scheme is to provide free Ante-natal and Post-natal check-ups, free distribution of medicines, injections, oral pills and other contraceptives to the expectant mothers desiring Family Planning services. Dr. Rynjah appeal to the mothers to avail this opportunity for their well being and also for the benefit of the family

Mr. D P Wahlang, DC, in his speech, appeal to all private sectors to kindly volunteer and join the Vande Mataram Scheme and cooperate with the Government in this matter. He also urged upon Headmen and NGOs to cooperate with the Government, by creating awareness about this scheme. He inform that his office together with the Office of the District Medical & Family Welfare will provide free consultation, medicines etc.

The Deputy Commissioner also informs that this scheme will be implemented on March 9, 2004, where a team of doctors from Ganesh Das Hospital will provide free Ante-natal and Post-natal check-ups, free medicines and free consultation at Mawsynram Community Health Centre. The service will cover Weiloi, Tyrsad, Mawsynram, Balat and adjoining areas.

Others who spoke on the occasion were Dr. S Nongpiur, Incharge Superintendent, Ganesh Das Hospital, who gave the welcome speech, Dr. R Wankhar, Gynaecologist and Dr. R Dkhar, District Maternal & Child Health Officer who deliver the vote of thanks.

Elsewhere, the Vande Mataram Scheme was also launched in Ri Bhoi District in a public function held at the premises of the Nongpoh CHC. The function was attended by mothers, NGOs, teachers, doctors and health workers under the Chairmanship of the Deputy Commissioner, Ri Bhoi District, Mr. W L Lyngdoh.

While speaking on the occasion, the Deputy Commissioner called upon the people to take full advantage of the scheme, which has been designed for the maximum benefit and is free of cost.

While the District Medical and Health Officer, Ri Bhoi District, Dr. T Swer informed the gathering about the facilities provided under this new scheme launched by the Central Government, others who spoke on the occasion included Dr. M S Mawrie, M & HO, Nongpoh, Mrs. B Sweetly, Representative of the NAAWA, Mr. D Nongshli, Headman of Saiden and Mr. S B Shimroy, Headmaster, Christian School, Nongpoh.
