### STATE GOVERNMENT OFFICIALS REVIEW FLOOD SITUATION IN GARO HIILS

**Shillong**, **July 20**, **2004**: A team of State Government officials, including Agriculture Commissioner, Mr. K.M. Kumar, Commissioner & Secretary, Health & Revenue, Mr. K S Kropha and Commissioner of Divisions, Mr. Peter Ingty arrived at Tura on July 17, 2004 to make an on-the-spot assessment of the flood situation in West Garo Hills District.

It may be mentioned that the flood situation in the plain areas of West Garo Hills remained static with no sign of improvement as the incessant downpour continued in the District. Over 4000 people have been rendered homeless with 11,000 people from 45 villages affected by floods. The State Government had sanctioned Rs 5 lakhs for undertaking relief work to the affected people.

The officials, after visiting the flood affected area at Phulbari, Rajabala, Tikrikilla and other places, held a review meeting with the District officials on July 18 at the Tura Circuit House. The Deputy Commissioner, Mr. S Jagannathan briefed the officials on the measures taken by the district administration to provide relief materials to the flood affected people and also the extent of damages to the standing crops in these areas due to incessant rains for the last two weeks.

Later, the Health Commissioner Mr Kropha also visited the Tura Civil Hospital and the construction sites of the 100-bedded Hospital Annexe and Maternity & Child Care Centre and expressed his concern over the existing state of affairs of the Hospital. He was accompanied by the District Medical & Health Officer Mrs. Mira Sangma.
