### PROPOSAL TO RESUME LEASED LAND AT RILBONG

**Shillong, June 25, 2004:** The Deputy Commissioner, East Khasi Hills District, Shillong, has notified that the Government of Meghalaya in the Revenue Department has proposed to resume the two lands at Rilbong covered by Patta No.23 plot No.36 (New Plot No.47) with an area of about 6720 Sq.ft and another covered by Patta No.39 Plot No.39 (New Plot No.46) with an area of about 2418 Sq.ft. These properties were leased out to Malvi Intaz Uddin Ahmed in Rilbong area within Kench's Trace, the leases of which expired in the year 1966 and the leesees have already migrated to Bangladesh.
